The officers mentioned above shall be provided all support / assistance and information by Police, Dy. Collector / SDM.

The duties of the team are as under and as per the directions of the Hon'ble Chief Minsiter from time to time.

- 1. The team members shall contact all Sarpanchas, Deputy Sarpanchas, Panchas Councillors and take information on violation by home quarantined citizens in the jurisdiction of the respective Sarpanchas, Deputy Sarpanchas, Panchas Councillors.
- 2. The team members shall also find out information of citizens who have returned from other states i.e. entered Goa from outside the state and are yet to be stamped and home quarantined.
- 3. The list has to be shared with the local PI who will take needful action.
- 4. It may be noted that all the information has to be gathered without divulging any names
- 5. The team members have to deal with any tasks allotted by the Hon'ble Chief Minister through this group as the situation evolves from day to day.
- 6. The contact names and phone numbers of the Sarpanchas, Deputy Sarpanchas, Panchas Councillors vis a vis constituency wise Panchayats and Municipalities shall be provided by Director of Panchayats and Director of Municipal Administration.
- 7. The team shall also obtain from the local representatives a list of citizens who are old, sick, physically challenged who shall require assistance in obtaining food supplies, medication which will be provided through door to door deliveries int he coming days. This list will thereafter be provided to the grocery, supermarket, bhagyatdar, pharmacy for needful.
