Essential Qualification: A person shall not be qualified for appointment as a member unless he is of not less than forty years of age and possesses an experience of at least ten years as presiding officer of a District court or of any tribunal at equivalent level or combined service as such in the district court and tribunal.

2. Name of the Post: Member

Total No. of Posts: 1

Essential Qualification: A person shall not be qualified for appointment as a member unless he is of not less than forty years of age and possess a bachelor's degree from a recognized university and is a person of ability, integrity and standing, and has special knowledge and professional experience of not less than twenty years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine.

Term of office of Members :-

Every Member of the Goa State Consumer Disputes Redressal Commission shall hold office for a term of four years or up to the age of sixty-five years, whichever is earlier and shall be eligible for reappointment for another term of four years subject to the age limit

of sixty-five years, and such reappointment is made on the basis of the recommendation of the Selection Committee.

• Salaries and allowances payable to Members of the State Consumer Disputes Redressal Commission are as prescribed under The Consumer Protection (Salary, Allowances and Conditions of Service of President and Members of the State and District Commission) Model Rules, 2020.

Essential Qualification: A person shall not be qualified or appointment as member unless he is of not less than thirty-five years of age; and possesses a bachelor's degree from a recognized university; and is a person of ability, integrity and standing, and has special knowledge and professional experience of not less than twenty years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine.

- Term of office of Members:The President and every Member of the District Consumer Disputes Redressal Commission shall hold office for a term of four years or up to the age of sixty-five years, whichever is earlier and shall be eligible for reappointment for another term of four years subject to the age limit of sixty-five years, and such reappointment is made on the basis of the recommendation of the Selection Committee.
