**ORDER**

**(Dated 19.06.2023)**

Mrs. Tema Narvekar, Special Public Prosecutor and Mrs. Cristina C. Dias are present.

Heard both the sides.

1. Witness Cristina Dias, after her cross examination almost over filed an application for time to produce the documents pertaining to
1. Entire mutation proceedings No. 80981 of the property bearing Sy. No. 39/6,
  2. Entire mutation proceedings No. 81054 of the property bearing Sy. No. 39/4,
  3. Entire mutation proceedings No. 80913 of the property bearing Sy. No. 47/1,
  4. Entire mutation proceedings No. 80860 of the property bearing Sy. No. 43/2,
  5. Entire mutation proceedings No. 81071 of the property bearing Sy. No. 43/9,
  6. Entire mutation proceedings No. 80828 of the property bearing Sy. No. 18/12, all situated at Village Assagao,
  7. Entire mutation proceedings No. 80977 of the property bearing Sy. No. 493/3 of Village Anjuna,
  8. Entire mutation proceedings No. 80976 of the property bearing Sy. No. 493/2 of Village Anjuna.

The witness Cristina Dias submits that all the documents as referred above, xerox copies of the same are already filed on record at 1) Page No. 93 to 119, 2) Page No. 209 to 243, 3) Page No. 244 to 280, 4) Page No. 283 to 326, 5) Page No. 327 to 351, 6) Page No. 352 to 424, 7) Page No. 425 to 477, 8) Page No. 483 to 535 and the Xerox copy of the Sale Deed at



Page No. 121 to 208. The application for time to produce documents is marked at **Exh. 88** and application for time to obtain certified copies is marked at **Exh. 89**.

Advocate Soumya Drago holding for Advocate Parag Rao has left it to the Commission for passing an appropriate order similarly the Special Public Prosecutor Mrs. Tema Narvekar has also left it to the Commission.

It appears that witness Cristina Dias has already filed an application before Public Information Officer, Office of Mamlatdar Bardez, Goa on 09/06/2023 for obtaining the certified copies of mutation proceedings under the provision of Right to Information Act, 2005. However, the certified copies are yet not received.


Witness Cristina Dias, however, admits that she has got the certified copies of said documents obtained on earlier occasion. She submits that she is ready to produce the same but it may be returned to her after the purpose is over by substituting it with the Xerox copies.

In view of the above and since the documents are pertaining to the mutation proceedings before the Mamlatdar, the Commission directs the witness to produce the certified copies and after exhibiting those certified copies she may file an application for return of the documents at the appropriate stage.

Applications **Exh-88** and **Exh-89** are accordingly disposed off.
