The Special Public Prosecutor Mrs. Tema Narvekar on instructions submits that so far as Folder No. 45 is concerned all the papers thereof have already been sent to Porvorim Police Station and the forwarding letter of Special Investigation Team is submitted before the Commission. The learned Special Public Prosecutor Mrs. Tema Narvekar submits that, however, the Crime is yet to be registered.
