1. The learned Counsel Advocate Parimal Redkar for the complainant Jagdeep Bansal in connection with Crime No. 65 of 2022 (Folder No. 2) submits the written notes of arguments, the same are accepted and the copies are already given to the Special Public Prosecutor Mrs. Tema Narvekar.

Mr. Rahul Chandrakant Desai, the accused in connection with Crime No. 75 of 2022 (Folder No. 4), Crime No. 76 of 2022 (Folder No. 5), Crime No. 139 of 2022 (Folder No. 8), Crime No. 130 of 2022 (Folder No. 10), Crime No. 58 of 2022 (Folder No. 31) and Crime No.146 of 2022 (Folder No. 32) has submitted the written notes of arguments alongwith the citations, the same is accepted and marked at **Exh. 19**. 
accepted and the copies are already given to the Special Public Prosecutor Mrs. Tema Narvekar. The written notes of arguments are marked at **Exh. 6**.

On 20.03.2023 one Mr. Francisco Carvalho, intervenor in the writ petition No. 1680 of 2021, has filed the Xerox copy of the letter addressed to Special Investigation Team and the Xerox copies of the documents. However, thereafter he has never turned up. He has not bothered to file the affidavit nor submitted the true or certified copies of the documents. Hence filed.

4. The learned Counsel S. Vaingankar holding for Advocate O. Fernandes for the accused persons in connection with Crime No. 54 of 2022 (F. No. 1), Crime No.65 of 2022 (F. No. 2), Crime No. 131 of 2022 (F. No. 9) has submitted the written notes of arguments alongwith the notarised copies of F.I.R. bearing F.I.R. No. 95/2022 registered with Crime P. S. The learned Counsel has also submitted an application alongwith the list of documents seeking leave to produce the documents. However, the same is allowed for the reason that the accused in connection with the aforesaid crimes have given reference in their defence statements about the F.I.R. No. 95/2022.
