The Public Information Officer shall on receipt of a request under Section 6, as expeditiously as possible and in any case within thirty days of the receipt of the request, either provide the information on payment of such fees as may be prescribed or reject for any of the reasons specified in Sections 8 and 9.

The above designated officer shall exercise and perform the powers/functions laid down under the RTI Act, 2005 with immediate effect.

Appeals against the orders of PIO shall be entertained by the Director of Information & Publicity.

This supersedes the earlier order of even number dated 05-08-2015.
